The Business domain stands out through additional benefits compared to Personal and Custom domains. Premium and Top Brands domains already include the specific benefits of the Business domain. Any Personal domain can be upgraded to the Business domains by paying a one-time Business domain fee, thereby facilitating access to all advantages associated with this type of domains.
- 3. Premium: This Premium category encompasses any domain containing less than 5 characters. These domains have a

- different price and can be acquired through a direct request to the company, automatically including the specific benefits of the business domain.
- 4. Custom: Any custom domain that does not directly reference a famous brand, a well-known name, or a name of a category or subcategory within the Sourceless ecosystem. Any personal custom domain can be upgraded to the business domain by paying a one-time business fee, thus gaining access to all the benefits associated with this type of domains.
- 5. Top Brands: Any name that refers to a famous, registered brand. The price of these domains is different and can be purchased through a direct request to SourceLess, automatically including the specific benefits of the business domain.
- 6. Non-Governmental Organizations (NGOs) and Governments: These domains can be provided for free if the institution associated with the desired domain name contacts us at the email address office@sourceless.io.
- 7. Categories: The str.domains platform is organized into various categories such as sports, automotive, music, etc., each having a specific number of subcategories. Business domains are classified within these categories and subcategories, having distinct prices reflecting the features and functionalities that can be activated into the Sourceless Ecosystem.
- 8. Subcategory: The str.domains platform is structured into specific subcategories within categories such as sports, automotive, music, etc. Each category has a predefined number of subcategories. Business domains are included in these categories and subcategories, having different prices that reflect the specific features and functionalities that can be activated.

## Limitation of Liability and Indemnity

We provide the Service and Assets as is, and we make no promises or guarantees about it. The arbitral award will be final and binding on the parties and its execution may be presented in any competent court, including any court with jurisdiction over either party or any of its property.

Each party will bear its own lawyers' and experts' fees and expenses, regardless of the arbitrator's final decision regarding the Dispute.

## Payment and Billing

STR.Domains may invoice You for Your use of the Services or purchase of Assets through an unaffiliated, third-party payment service provider. The third-party service provider's terms of service shall govern and supersede this Agreement in case of conflict.

At any point prior to decentralization, if your use of the Assets violates this Agreement, STR.Domains may at its sole discretion revoke your license to the Asset(s) in exchange for a full refund.
